Fall Road Maintenance Projects

The HOA will be having road maintenance work done this upcoming week, starting Monday 10/14 around 8 am and going until Wednesday or Thursday. <u>Click here for a map</u> of some of the more significant project, but in general the roads will be graded, have potholes removed, and additional gravel placed around the neighborhood.

Dennis Gibson, a local contractor, will be conducting the work and will have several pieces of equipment out for the various stages. He will try to minimize the impact to community traffic and activity but the nature of the projects will influence the access around the neighborhood at varying times. Specifically, *McLoughlin Drive will be closed part of the day Monday (10/14)* for the culvert replacement project located between lots 36 and 51 but should be open by the afternoon. Most other projects shouldn't result in full road closures but may involved delays for equipment to move out of the way.

Please add extra time for your drives around the neighborhood to allow for some interruptions due to this road work and drive cautiously as there will be dump trucks and equipment out on the roads. Drainfield Easement - Please review!

Following the PVHA Annual meeting in May, the board has been working with the HOA's lawyer to develop a revised septic drainfield easement for Jonald Gradwohl's (Lot 54) request on the community property located on the norther side of Whitman Way. During the annual meeting the board was approved to move forward with the easement, contingent upon revising the easement's wording to ensure that pre-existing community systems, like the water and septic lines, are included as having senior rights in the area, and indemnifying both the PVHA and Pioneer Village Water Company from any potential damages that may occur due to one of our systems failing.

The board is now posting the revised easement written by the HOA's lawyer for community review and comments. <u>Click here to open the document as a pdf.</u> It will be posted for a period of 14 days, during which time comments and questions can be emailed to Anna via <u>admin@pvha.us</u>. At the end of those 14 days - July 10, 2019 - the board will meet and determine if further revisions are necessary to address the comments otherwise will proceed with granting the easement as voted on during the annual meeting. An update will be posted to inform everyone once things have been finalized to ensure that everyone is aware of the process.

It's summer! It's Fire Season!

The warm, dry weather has resulted in ODF and ODEQ posting "no burn" notices a week earlier than usual. No outdoor burning except in BBQs and designated fire pits. Spark-arresters are required on any equipment used in the forest (including Pioneer Village!) such as chainsaws. Please do not drive any type of vehicle off the roads as a spark of any kind can start the grass and brush on fire.

Please fill out a form in the plastic box on the whiteboard (behind the bear notices) to tell us what you have done to create defensible space around your home this year. Filled out forms can be returned to the PVHA mailbox by October 1.

Chipping - first week in May

Please bring all brush to the chipping pile at the school bus turnaround by the end of April. Chipping is provided by the county and Oregon Department of Forestry. they will be here sometime during the first week of May. Keep in mind that only brush should be on the pile.

NO:

- straw, grass, or other compost
- poison oak or blackberries
- lumber or painted wood
- nails, wire, or metal of any kind

• branches larger than 6 inches in diameter

It is fire season already! (March 20, 2019)

You may have heard about the Santiam Park Fire on the news last night. It is a 90+ acre fire burning near the North Santiam in Linn County. Evacuation alerts have been issued. And it is only the first day of spring!

There was a brush fire even closer to home yesterday. At approximately 12:30 in the afternoon a brush fire was called in on Crystal Creek Loop (old Hwy 20) in Lincoln County. Gusty winds pushed a fire, most probably started by powerlines coming in contact with tree limbs, upslope threatening 1 home and 3 outbuildings. The fire burned a total of 9 ½ acres before being contained by firefighters from Toledo and Philomath ODF and Toledo, Philomath, Seal Rock, Siletz and Depoe Bay rural fire departments (nearly 40 firefighters in all). There was some damage to outbuildings from embers and water but none were lost. Firefighters commented on how dry the understory is. And it is only the first day of spring!

Do not be fooled by the late snow and cold of the winter weather. These local fires emphasize the importance of pre-fire season cleanup and fuel reduction projects around your property. Use caution when burning debris (only on authorized "backyard burn" days!). The brush pile by the school bus turnaround is growing by the day! This is great! The County and ODF will pay for chipping in late April or early May, so get your brush cleared out soon!!
