#### **BOARD TO-DOs**

### **GENERAL INFORMATION**

#### A friendly reminder to:

- Always drive slowly and cautiously around the community. The Speed Limit is 15 MPH to protect EVERYONE's safety
- Keep Fire Lanes clear of parked vehicles and debris at all time, they are critical to ensuring emergency vehicle access
- Make sure your dogs are good neighbors as well and control them around your property and when out on walks.
- Help keep roads in good condition by blowing dirt, leaves, and fir needles off throughout the year

## COMMITTEE REPORT - Architectural Control Committee (ACC)

- **5** Lots Represented (lots 20, 33, 35, 44, 58) on the ACC
- Generally 1-2 week typical turnaround time however, the ACC has 30 days to review

## COMMITTEE REPORT – COMMON SEPTIC SYSTEM (CSS)

- The Common Area field is an operational drainfield with semidelicate lines running underneath it
  - Very limited vehicle access is permitted with HOA approval
  - No horse traffic is allowed because of the potential to the break lines
- Please do not remove the orange markers in the field. They are there to help the inspections and for drainfield maintenance
- Spring maintenance was completed in March, 2023
- 2023-2024 Annual User Fee to stay the same as last year (\$125/household)

### **COMMITTEE REPORT – FIREWISE**


#### **PVHA Forest Thinning Project**

#### Purpose

- Maintain a *healthy native forest* to provide multi-generational value to the neighborhood and continued residential property value.
- Wildlife habitat enhancement / Fuel reduction / wildfire mitigation / hazard reduction

#### Proposed Actions

- Identify and harvest a subset of trees in Area #1 to result in optimal spacing and encourage circumference growth of trees to avoid further tree mortality.
- Remove hazard trees, while encouraging Douglas-fir, oak, and maple.
- Chip/mulch debris remaining from harvest to return nutrients to the forest soil and reduce fuels.
- Seed with native grasses and forbs to stabilize soils and deter invasive plant growth.



### COMMITTEE REPORT – FIREWISE

#### **PVHA Forest Thinning Project**

#### Desired Result

- Healthy, uneven age stand of mixed conifer and hardwoods with native trees, shrubs, and forbs.
- Reduced buildup of fuels and increased open space for fire protection and control.
- Improved wildlife habitat due to improved stand health and focus on native vegetation.

#### Why Now?

- Tree density is beyond optimal and most of the trees are small for their age or already dying.
- Increased community awareness and focus on forest health and fire safety.
- Timber prices make the work economically feasible.
- Need to increase forest resilience to climate change.
